**4<sup>TH</sup> ADDENDUM FOR LOCAL OPEN TENDERS FOR CHIRUNDU UPGRADE PROJECT**

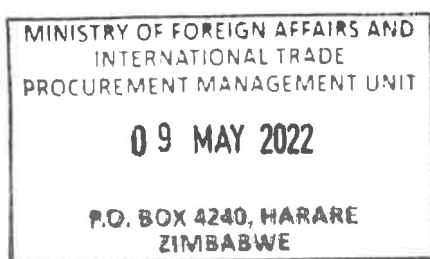
