## CVID-19 MEASURES in MEMBER STATES

As at 4 December 2020 / 32nd Edition

This publication comprises a listing of measures that COMESA Member States have put in place to contain the spread of the Corona virus. They cover trade facilitation and support to businesses, protection of the vulnerable from the impact of the spread of the virus and other relevant measures. It also includes the support received from the international community Aid agencies. A trendline on the number of cases reported has also been included as well as the contacts of the focal points in the Ministries that coordinate COMESA activities in Member States. This document will be updated on a regular basis to take into account the new measures that governments are putting in place in response to changing circumstances.

The data and information are drawn from monitoring press briefings of the national COVID-19 response task forces and other open sources.

Preventive Measures in Place	<ul> <li>Lockdown was declared on 2nd April 2020.</li> <li>Since 26th March 2020, commercial airline flights in and out of Eritrea were suspended. Land borders were also closed.</li> <li>National Task Force on COVID-19 was established at high and lower levels and has been issuing regulations and implementing Guidelines.</li> <li>All entry visas to Eritrea suspended since April 2020.</li> <li>All citizens, except those engaged in indispensable developmental and security tasks directed to stay at home.</li> <li>Only a maximum of two members of a household are allowed to go out from their homes to buy essential food items during the day. Residents of Asmara, frontline health workers, and residents of border areas are targeted.</li> <li>Food production, supply and processing enterprises as well as grocery stores, pharmacies and banks will continue to provide services. - Government registries and the courts closed except for the handling of emergency matters.
- Government offices, businesses and companies encouraged to allow employees to work from home except for those working in critical or essential services.
- Kenya Medical Research Institute develops a local testing kit
- Resumption of domestic air travel from 15th July. International flights resumed on 1st August 2020.
- Mandatory PCR-Covid-19-Free certificate for all international arrivals valid for 96 hours prior.
- Mass production of sanitizers, masks and ventilators by private sector in Kenya.

Measures in Place Flights resumed at the Mitiga Airport in the Libyan capital Tripoli on 9th August 2020.

- By 8th August 2020 the European Union mobilized €20 million (LYD 33 million) to assist Libya in responding to the COVID-19 pandemic. The funds will contribute to improve national detection and surveillance mechanisms in the fight against the spread of the coronavirus, boost preventive measures and support Libya's national health system.
- Reopening of restaurants and cafés from 7th July 2020 on under strict conditions.
- A primary healthcare centre in the Gergaresh neighbourhood of Tripoli serving a catchment area of at least 30,000 people, including high concentrations of refugees and migrants from sub-Saharan Africa re-opened from 15th July 2020 to deal with the rising numbers of COVID-19 cases.
- Starting on 31st July 2020 the Government of National Accord based in Tripoli imposed a lockdown in areas that it controls for a period of 5 days. The lock down replaced the previous curfew that had been in place from 9 pm 6 am. In the East, in areas controlled by the Libyan National Army (LNA), the curfew remains 6 p.m. to 6 a.m.
- On 31st August 2020, High schools in Libya reopened for the new semester with precautionary measures including providing sanitizers, face masks and thermometers to teachers and student returning to school this year is optional for students and they can choose whether to go back to school or not.
- A special committee that includes the ministries of interior, finance and health formed to develop a policy and procedures for repatriating Libyans from abroad.
- The Supreme Committee for Combating COVID-19 closed all vegetable and meat markets, but bakeries and some shops remain open to meet people's needs.
- Points of Entry (PoEs) to screen travelers arriving from affected areas established at three airports (Mitiga, Misrata and Benina), four seaports and land border entry points at Ras Ijdier, Wazen and Msaed.
- Testing is being undertaken for truck drivers travelling over the Tunisian/ Libyan border with drivers required stay for 14 days in Zwara for quarantize.

Authorities in both the West and East have started to repatriate Libyan citizens stranded overseas (those wishing to return are in Egypt, Tunisia and Turkey). Returning citizens are tested and allowed to quarantine at home for 14 days.
Following government directives issued on 14th November 2020, Libyan authorities reopened the land border with Tunisia.
Cargo transportation exempted from ban
Eastern authorities reopened borders from 31st August 2020.

  - Live performances and cultural shows to resume and will have to adhere to COVID-19 preventive measures.
- On 9<sup>th</sup> November 2020 the Government announced a number of measures to contain the rising cases of COVID-19 infections in prisons. These measures are:
  - Treatment and testing centres to be established in every prison where cases have been reported;
  - Deployment of medical personnel in affected prisons where contact tracing and testing will be carried out in order to ensure that COVID-19 spread is contained;
  - Relatives of inmates will not be allowed to visit and can only send money through mobile money transactions;
  - Prisons will be decongested by sending some of the inmates to participate in community services;
  - Separation of aged inmates from other inmates as they are more vulnerable to the disease;
  - New inmates will be put under a two-week quarantine period before joining others and those who are discharged must be tested before joining their communities;
    - All persons supplying goods to prisons must undergo COVID-19 testing.
- On 11th November 2020 the University of Rwanda announced that it will reopen for first and second-year students effective on November 30th 2020.
   The students will join their third, fourth and fifth-year counterparts who resumed in-person class sessions since October 2020.
- On 5th November 2020 the Rwanda Development Board (RDB) announced that massage therapy services are allowed to open after being closed since March 2020. However, both sauna and steam services will remain closed until further notice. When operating massage therapy centres will ensure strict adherence to COVID-19 health guidelines.
- On 5th November 2020, Rwanda reopened its border crossing with DR Congo at the Gisenyi/ Goma border to ease small-scale cross border business. The reopening is in line with a Memorandum of Understanding reached on 2nd November 2020 between the two countries. As part of preventive measures and trade facilitation measures.
- Movement to be allowed for passport holders and those with temporary travel permit, unlike previously when people also used national IDs to cross.
- Travelers to follow health protocols, including rapid tests for COVID-19 before being allowed to proceed to their destinations.
- New measures were announced on 3rd October 2020 with regard to the reopening of learning institutions.
- On 13th October 2020, Government announced the school calendar for the

year 2020-2021.

- Public transport between Kigali City and the rest of the country prohibited from 27th August 2020. Other prohibitions are private transport movements between Kigali and other districts.
- Beginning 12th October 2020, public transportation to continue with buses operating at full capacity for seated passengers and at 50 percent for standing passengers; and further guidelines to be provided by the Rwanda Utility Regulatory Agency (RURA).
- From 1st September 2020, all public hospitals to start COVID-19 tests in a move to boost capacity and will apply the PCR technology.
- Curfew reviewed as from 12th October 2020 to start from 10 p.m. to 4 a.m. The earlier curfew had been set at 10 p.m. to 5:00 a.m. Movements are restricted within that time.
- As from 26th August 2020, the number of people working in public institutions at any given time reduced to 30% from 50% and required to work in shifts.
- Beginning 26th August 2020 employees working in the private sector including markets to continue observing the 50% quota of employees at any given time.
- From 14th August 2020 new arrivals to Rwanda must present a negative COVID-19 tests certificate done within 5 days of departure from their point of origin. Initially, international travelers were required to have the tests done within 3 days (72 hours).
- Government established an online platform for people in need of essential services including visiting hospitals, attending to emergencies, shopping etc. to apply for clearance of movement.
- Commercial flights to and from the country were allowed to operate as from 1st August 2020. RwandAir resumed international flights on 1st August 2020 starting with Africa routes. RwandAir to resume weekly flights to the London and Brussels routes beginning October 3rd, 2020. Health measures put in place to safeguard the health of passengers, crew, and airport staff as provided by Ministry of Health and ICAO.
- Places of worship resumed services from 16th July 2020 with approval by local authorities.
- Beginning 1st August 2020 self-check in kiosks, thermal cameras, screening robots, and hand sanitizer dispensers have been put in place at Kigali International Airport as part of health measures.
- All visitors travelling to Rwanda by charter flights must test negative for COVID-19 within 72 hours prior to arrival; a second test will be taken prior to visiting any tourist attraction.
- Domestic and international visitors travelling for tourism by charter flights allowed in the country from 17th June 2020.
- Domestic and international tourists visiting Volcanoes National Park, Nyungwe National Park, and other parks must test negative for COVID-19 at their own cost - within 48 hours prior to visiting the parks.
- All passengers arriving in Rwanda by commercial flights including those in transit required to show proof of a COVID-19 PCR negative test from a certified laboratory taken within 72 hours of arriving in Rwanda. A second PCR test to be conducted upon arrival – with results delivered after 24 hours.
- Apart from the national Kigali National Reference Laboratory, other satellite testing labs set up in COVID-19 hotspots areas of the country which include the districts of Kirehe, Rubavu, Rwamagana, Nyagatare, and Rusizi, This is to hasten the process of generating results for patients to ensure timely interventions.
- Beginning 12th October 2020, venue capacity for participants in meetings and conferences raised from the previous 30 percent to 50 percent and participants no longer required to show proof of COVID-19 tests conducted within past two weeks.
- Hotels to operate and offer tourism and conference services but must adhere to the provided health guidelines.
- Religious wedding ceremonies allowed to take place but should not exceed 30 people.
- Restaurants and cafes allowed to operate until 7;00 p.m.
- Social distancing to be observed in public places.
- Wearing of face masks is mandatory in public places and multi-family settings.
- As from 22nd July 2020 all staff of national parks, airports, and hotels near

- Beginning 12th November 2020, all travelers to Seychelles are required to take a COVID-19 PCR test on the sixth day after their arrival as part of reinforced measures in response to the acceleration of the outbreak in several parts of the world. The cost of the test, which will be done on both foreigners and Seychellois citizens travelling to Seychelles, will be covered by the Government.
- On 2nd October Seychelles reviewed its Visitor's Travel Advisory and put in place new advisory as follows:
  - a. Travelers from all countries are allowed to enter Seychelles. These have been divided into 2 categories namely: Category 1 which includes permitted countries from low and medium risk; and Category 2 which consists of countries from the list of seven countries given special status (Italy, France, Germany, UK, Switzerland, Austria and the United Arab Emirates (UAE).
  - Category 1 of permitted countries will be subjected to a set of different measures amongst which are: will not be subject to special conditions imposed for category 2 countries. In addition, a COVID PCR test prior to travel should be no more than 72 hours;
  - c. Category 2 will be subjected to a set of different measures amongst which include:
    - Visitors will be allowed in Seychelles even if the COVID-19 situation in these tourism markets keeps changing;
    - Visitors to ensure that all requirements are met before arrival failing which may result in restriction of entry;
    - Adherence to all stated procedures in the Visitor's Travel Advisory;
    - COVID PCR test prior to travel should be no more than 48 hours;
    - Visitors to stay within hotels designated for Category 2 countries;
    - Restricted movement for visitors for the first 5 days of the stay in Seychelles and will be monitored by the staff of the hotel
    - On the fifth day, a second PCR test to be done and if test is negative, they can leave the hotel premises.
- In addition, Seychelles has also accredited category 1 and category 2 hotels, including specific training to hotel staff to handle visitors from different countries based on COVID-19 risk. Under this arrangement, a hotel can be certified as both a category 1 that is welcoming guests form low-risk countries and category 2 for the high-risk countries. At least 74 hotels have been accredited and published in the visitor's information for category 2 permitted countries and are subjected to regular updates by the Tourism Department.
- On 15th September 2020, Seychelles adopted a new technology called Travizory technology to facilitate the collection and analysis of travelers' documentation that will ensure re- opening of the borders in the safest manner. Among other features, the technology allows:

- a. Seychelles health authorities to collect in advance identity and health information directly from the traveler via the easy-to-use web version and mobile apps.
- b. Authorities to run rapid and efficient vetting procedures to minimize COVID-19 risks and other security risks.
- c. Travelers to apply from their mobile phone via Android or iOS apps or on the web in about five minutes.
- d. Travelers to receive a clear response on their eligibility to travel in the form of a secure barcode, also available as a wallet pass, which they can present at check-in and boarding. With the use of the technology travelers will be required to pay a fee of US\$50 under normal conditions or US\$150 for emergency and late submissions.
- On 14th September 2020, Seychelles introduced a new public health order that makes wearing a mask mandatory as follows:
  - when using public transport (which includes buses, ferries, taxis and other means of transportation) and in places where sufficient distancing is not possible.
  - in all indoor places where a one-metre physical distancing cannot be maintained as well as outdoor places like sports venues, markets and bus terminals.
  - in places such as financial institutions, customer service centres, retail shops or outlets, funeral places, meeting rooms and cinemas.
- International Airport opened on 1st August 2020 to commercial passenger flights from low and medium risk level COVID-19 countries. Process guided by the national framework for the integrated management of reopening of Seychelles borders which has a criteria for classifying countries into low, medium and high risk.
- Application for international flights carrying passengers to be made to Public Health Commissioner (PHC).
- A standard form (application for entry into Seychelles by air and sea) available on DoH website to be completed and submitted.
- Applications to be processed on a case by case basis as per Public Health Order
- All child-minding and day-care services, all post-secondary institutions including A-Levels, Guy Morel Institute and the University of Seychelles Primary and Secondary Schools reopened in May 2020.
- Improvement of handling capacity of quarantine and treatment facilities, including the finalization of a programme to receive additional human resource support if necessary.
- Additional \$3.6 million provided to health sector through national budget amendments.
- Seychelles secured an African Development Bank (AfDB) loan of US\$10 million to support the Government's COVID-19 response programme.
- All restrictions on the movement of people removed.
- Religious services, including funeral services, have resumed following guidance from the Department of Health.
- All shops able to stay open until 8 pm in the evening.
- The majority of services and businesses reopened. Construction companies have resumed their work as per guidance issued by the Department of Health
- Conduct of funeral procedures at the cemetery under strict guidelines as set out by the Department of Health.
- Government issued new Seychelles Safety Travel Guidelines
- Gymnasiums and fitness facilities opened
- Sporting activities have resumed, following guidance from the Department of Health.
- Leisure boats and yachts able to enter Seychelles territory, respecting any guidance from the Department of Health.
- Ban on all cruise ships in Port Victoria until end of 2021.
- Indoor seated public shows or gatherings, conferences and meetings held per health guidelines and sports competitions that will take place without spectators allowed to resume.

Preventive Measures in Place

- On 29<sup>th</sup> October 2020, the Government issued a number of COVID-19 measures including:
  - Revision of the overnight curfew and extended across Tunisia whereby the curfew has been brought forward by an hour to 20:00 hours to 05:00 a.m. (local time). A longer 19:00 - 05:00 curfew also applies across the country at weekends.
  - issued a ban on non-essential movement between the country's governorates, with domestic travel being limited to work-related trips and other essential journeys;
  - a 16:00 hours closure time for cafes and restaurants, a ban on protests, and a four-person limit on public gatherings.
- On 15<sup>th</sup> October 2020 Governor of Sousse Governorate, Raja Trabelsi, extended the night curfew by 10 days to stem the spread of Covid-19. The curfew will be in force in the entire governorate from 8pm to 5am.
- On 14<sup>th</sup> October 2020 Tunisia finalized measures to be administered for passengers travelling from high-risk countries, categorised as the 'red zone' of travellers. According to the measures, passengers required to present themselves at the departing airport three hours in advance to commence precheck in activities, and present two printed copies of payment receipts for a seven-day quarantine at a hotel in Tunisia.
- On 13<sup>th</sup> October 2020, the German company Van Laack distributed 10,000 face masks in Bizerte for free. Additionally, the company offered 3,000 medical smocks to the staff of hospitals in the governorate of Bizerte.
- On 5<sup>th</sup> October 2020, the Sports ministry suspended youth and sports events, as well as official sports competitions and exhibition games, for 15 days, with the possibility of extension if required. As part of the measures, national teams must carry out COVID-19 tests and ensure they are negative so as to continue training.
- On 5<sup>th</sup> October 2020, the government announced plans to recruit 3,000 healthcare staff to support public hospitals as part of an exceptional hiring drive.
- On 3<sup>rd</sup> October 2020, the Prime Minister banned all gatherings and public or private demonstrations.
- Educational institutions opened on 15th September 2020 and must adhere to the following measures:
- Mandatory wearing of protective masks for all staff in educational and training facilities.
- Screening and monitoring at the entrances to educational and training institutions.
- Cleaning and disinfection of toilets and educational and training facilities.
- Conducting awareness campaigns and provision of psychological support for children, pupils and students. The curfew imposed in Kef province from 19:00 – 04:00 to contain the spread of the virus the curfew will be in place until mid-September 2020.

	• •	On 21st August 2020 Tunisian authorities reinstated a curfew in El Hamma from 5 p.m. to 5 a.m. after a spike in novel Coronavirus cases for a period of one week. Trains from Tunis to the city of Gabes, which services El Hamma, have also been cancelled. Overnight curfew re-imposed in greater Tunis form 8th October 2020 for 15 days. Preventive Measures in Place

- Beginning September 2020, COVID-19 testing centres established in all the 10 provinces.
- Learning institutions including schools, colleges, and universities re-opened on 21st September 2020. However, the learning institutions will follow COVID-19 prevention guidelines.
- Beginning 11th September 2020 bars and nightclubs to open and operate from 18:00 hours to 23:00 hours from Friday to Sunday.
- On 26th August 2020 the Ministry of Transport and Communications issued standard operating procedures that all public transport operators should comply with which include:
  - carrying the number of passengers in accordance with the registration requirement in order to curb overloading;
  - mandatory masking by drivers, conductors and passengers as well as frequent and routine sanitization of public passenger vehicles.
- Other measures include provision of handwashing materials and hand sanitizers in public transport vehicles, mandatory temperature reading, and ventilation. Public transporters who violate the measures risk withdrawal of their licenses.
- From mid-August 2020, Zambia among other seven African countries (alongside Liberia, Sierra Leone, Zimbabwe, Cameroon, Nigeria, and Morocco) to start administering the Coronavirus antibody tests as part of efforts to understand the extent of the outbreak on the continent.
- Citizens who have tested positive but are not showing any symptoms are allowed to go in self-isolation and strictly observe health guidelines. Health officials must conduct surveillance on such persons to monitor their situation.
- Patients who have tested positive and have underlying illnesses such as tuberculosis and HIV/AIDS placed under quarantine in government designated health facilities.
- All travelers coming into Zambia will be required to provide a negative COVID-19 (SARS-CoV-2) PCR test result. The test should have been conducted within the previous 14 days prior to arrival in Zambia. Travelers who do not meet this requirement will not be allowed into Zambia.
- Health screening conducted at all entry points.
- The Kenneth Kaunda International Airport in Lusaka remains open.
- Conferences, meetings and workshops involving large groups of people banned;
- Restaurants, cinemas, gymnasiums, and casinos open but must continue adhering to the stipulated public health guidelines.
- Hotels and lodges resumed normal operations as from May 2020.
- Police restrict numbers of people visiting inmates and suspects in police detention.
- Prison authorities to ensure detention facilities are not overcrowded.
- Social distancing of at least one to two meters to be observed in public places.

On 27th October 2020, the Government announced new measures as follows: **Preventive** Phased re-opening of land borders as follows from 1 December as follows: **Measures in** Border posts that fall into the first phase are Beitbridge, Plumtree, Place Victoria Falls, Chirundu, Nyamapanda and Forbes. The borders will open first to private passenger vehicles and pedestrian traffic from 1st December 2020, while further assessment will be undertaken with regard to preparations for handling public passenger transport. Cross-border public transport to remain barred until further assessments have been completed. Border operating hours for private traffic at the points of entry fixed at between 6am and 6pm until further assessment of the situation. The National Railways of Zimbabwe (NRZ) will resume commuter train services in Bulawayo on 2nd November 2020 with measures in place to prevent the spread of Covid-19 as follows: Coaches will be disinfected every day. Passengers will also have temperature measured and required to wash or sanitize hands before boarding the train. People suspected to be infected with Covid-19 will not be allowed to board the train. Passengers will be required to wear face masks in adherence to Covid-19 regulations. Passengers without face masks will not be allowed to board the train. Security personnel will be deployed aboard trains to ensure strict enforcement of Covid-19 regulations Passengers can pay train fares using cash, Point of Sale (POS) machines or mobile money according to NRZ. The commuter train service will run from Monday to Friday and there will be no service during weekends and public holidays. Relaxed curfew hours to start from 10pm instead of 8pm for the convenience of those who are cleared late at ports of entry. On 4th October 2020 the Government announced that Zimbabweans in South Africa will be allowed to return without seeking clearance from the Department of International Relations and Cooperation (DIRCO) in South Africa under the following procedures: Passage to the country to be subjected to relevant Covid-19 regulations as put in place by health authorities;

- This facility also covers those with permanent resident permits in Zimbabwe;
- Zimbabweans with valid South African permanent residence and other permits such as work, and student permits will also be allowed to cross into South Africa and back home.

On 22nd September 2020, the Government announced that:

- primary and secondary schools will gradually reopen from 26th October 2020 for all learners. Students sitting for Grade 7, Ordinary and Advanced Level Zimbabwe Schools Examinations Council (Zimsec) examinations required to return to class on 28th September 2020 to start preparations for final examinations. Other non-examination classes will return to schools in phases.
- Rest of non-examination classes resumed on 9 November 2020
- International flights resumed on 1st October 2020.
- the re-opening of the Registrar-General's Office to allow access to registration of births.
- On 15th September 2020, Government approved the resumption of inter-city travel to facilitate the smooth movement of examination candidates, citizens and visitors based on the following conditions:
  - Transporters who wish to ferry passengers should register with the Ministry of Transport and Infrastructural Development.
  - Transporters to strictly comply with Standard Operating Procedures for the sector which are compliant to the WHO guidelines and all COVID-19 regulations.
  - In support of this service, the Vehicle Inspection Department to resume its services.
- Air Zimbabwe resumed domestic and regional flights as follows:
  - Domestic flights and regional flights resumed on 23rd September 2020 and 3rd October 2020, respectively.
  - The regional Harare-Dar es-Salaam-Harare schedule will initially operate every Tuesday and Saturday.
  - All passengers to be tested for Covid-19 within 48 hours before travelling
- On 15th September 2020, Government reopened the Central Registry department for the resumption of services amid a backlog of critical documents such as birth certificates and passports.
- On 15th September 2020 the Zimbabwe Electoral Commission (ZEC) lifted the suspension of electoral activities. This lifting allows the following:
  - Finalization of the Covid-19 Policy on electoral activities by the Commission which is accessible to the public on the ZEC website <u>www.zec.org.zw</u>.
  - Publication of electoral timelines for all pending by-elections in the press through notices.
  - Holding of Parliamentary and local council by-elections with the Commission applying procedures to reduce the risk of Covid-19 infection.
- Beginning 4th September 2020 COVID-19 measures have been relaxed in Zimbabwe as follows:
  - Returning residents with a negative PCR test certificate conducted within 48 hours of departure will not be quarantined.
  - Returning residents without a PCR test conducted within 48 hours of departure will proceed to a quarantine facility where they will be tested before being discharged.
- On 27th August 2020, the Zimbabwe Prison Correctional Services (ZCPS) rolled out COVID-19 provincial awareness campaign in Masvingo province
- On 24th November 2020, Zimbabwe intensified measures to ensure strict adherence to COVIFD-19 regulations that have not been adhered to. These include closure of public bars, night clubs, beerhalls, betting shops and theatres s well as regulations for authorized public events such as weddings and church sessions that are limited to 50 and 100 persons, respectively.
- On 23rd November 2020 All travelers from Tanzania will be tested for Covid-19 at Zimbabwean points of entry using the PCR test

On 12<sup>th</sup> November 2020, Zimbabwe resumed consular services in Eswatini and Mozambique. The consular services in Eswatini and Mozambique had been temporarily shelved at the peak of the Covid-19 lockdowns in March 2020.
 Facilitation / • The Zimbabwe Tourism Authority (ZTA) announced that it will hold its first ever

virtual Sanganai/ Hlanganani World Tourism Expo from 22<sup>nd</sup> – 23<sup>rd</sup> October 2020 to ensure a platform for exhibitors and buyers is maintained amidst COVID-19.

- On 26th August 2020 the Zimbabwe United Passenger Company (ZUPCO) rolled out a solar-powered self-sanitization booth at one of the terminuses in the Harare Central Business District (CBD).
- On 26th August 2020 the Zimbabwe National Statistics Agency (ZimStats) began a door-to-door enumeration exercise as it prepares for a COVID-19 Epidemiological Prevalence Survey to be conducted in September 2020.
- On 25th August 2020, the Government extended from 3 months to 6 months unpaid sick leave for COVID-19 positive civil servants.
- On 24th August 2020, in order to enhance testing capacity at Beitbridge border point, laboratory personnel at Beitbridge district hospital were trained on the Abbott Platform which is capable of testing 94 COVID-19 samples at one go.
  - On 18th August 2020, the Government reviewed the lockdown measures as follows:
    - (i) Immigrants who have tested negative for COVID-19 would no longer be detained upon arrival in the country;
    - (ii) Business hours extended from the initial 8 am 3 pm to 8 am 4.30 pm;
    - (iii) Curfew revised from 8 pm 6 am to 10pm 6am;
    - (iv) Public transport drivers to undergo regular PCR tests
    - (v) Public transport buses to be allowed dedicated lane at roadblocks to expedite their passage.
- On 18th August 2020, the President launched a virtual Cabinet meeting systems to be used for Cabinet business and to be conducted at three different venues as follows:
  - (i) The State House Tent
  - (ii) The Cabinet Room
  - (iii) The Munhumutapa Boardroom.
- On 3rd September 2020, the Government announced the full resumption of all tourism activities. However, restrictions on inter- city and inter-provincial travel to be maintained.
- Zimbabwe among seven other countries that include Liberia, Cameroon, Sierra Leone, Nigeria, Morocco, and Zambia that will start administering Coronavirus antibody tests beginning from the week of 24th August 2020 in the hope that this will help in reopening the economy.
- Designation of journalists as an essential service (SI 93 of 2020)
- Reduction of employee attendance at government and private workplaces (except for critical staff).
- Gazette Public Health (Covid-19 Prevention, Containment and Treatment) Regulations 2020 on 23rd March2020 to allow for compulsory testing.
- To ease the situation in quarantine and isolation facilities, the Government adopted new World Health Organization (WHO) guidelines that allow asymptomatic and symptomatic COVID-19 patients to be discharged after 10 days and 13 days, respectively.
- Mass testing intensified.
- Use of schools by churches banned as from 8th July 2020 to reduce the risk of infections when schools reopen.
